

Best Ride

Your car, our driver, The Best Ride.

Agreement

1. I request Best Ride and its affiliated companies to provide a driver to drive my automobile as requested by me and so authorizes such driver. If for any reason I wish to be assigned another driver, I will contact Best Ride before trip.
2. I believe my automobile is in good, safe condition and I have no knowledge of conditions to the contrary.
3. I understand that alcohol consumption is only permitted in a limousine, sedan and SUV type vehicle with a solid division between driver and client. I understand that drug use or any drugs on my possession is prohibited by law. I understand that any illegal arms in my possession are prohibited by law. I understand that my vehicle cannot be loaded beyond seating capacity.
4. I certify that I carry automobile insurance providing minimum liability limits of bodily injury, accident, property damage, collision and comprehensive coverage, that there are no driver restrictions in the policies and those policies are in full effect.
5. I will advise Best Ride of any changes in the condition of my vehicle or insurance coverage.
6. I understand that my vehicle insurance is primary, with respect to any insurance Best Ride may carry, for liability, collision and comprehensive coverage and that Best Ride's responsibility is limited to the amount of my deductible or \$150 (whichever is less) for physical damage to my vehicle resulting from the negligence of a Best Ride driver.
7. If I provide a rental vehicle, the following additional terms apply:
 - a. I authorize the car rental company to provide all necessary information concerning my car rental reservation to Best Ride.
 - b. I understand the rental agreement will be in my name and the Best Ride driver will be deemed to be an additional authorized driver of the rental vehicle under the rental agreement.
 - c. If I, at any time during the rental, become aware that the rental vehicle is in unsafe condition, I will contact the car rental company for assistance and if needed, have the rental vehicle exchanged.
 - d. Regardless of any liability protection the car rental company may provide to me as part of the rental, I understand it is my responsibility to provide non-owned / hired automobile insurance with minimum liability limits of \$250,000 bodily injury each person / \$500,000 each accident, \$50,000 property damage, collision and comprehensive coverage for the benefit of Best Ride. I agree that between myself and Best Ride my insurance will be deemed primary.
 - e. If the driver is to pick up a rental vehicle on my behalf, I hereby authorize the driver to do so, upon presenting the driver's license and the car rental company confirmation number, as my agent; to initial and sign the rental agreement, as presented to the driver by the car rental company, on my behalf; and to do those things that are reasonable and customary in connection therewith, including but not limited to, executing the car rental company's form to authorize the driver to be an additional authorized driver of the rental vehicle.

f. If the driver is to return the rental vehicle on my behalf, I hereby authorize the driver to accept all charges as presented by the car rental company at the time of return.

g. If the driver picks up a rental vehicle on my behalf, billable time commences 1 hour before the driver reports to our designated pick-up point. If the driver returns a rental vehicle on my behalf, billable time ends 1 hour after I am dropped off. Additional hourly charges may apply if the designated pick-up or drop-off point is greater than five miles from the car rental company office location.

8. After I evaluate the performance and potential of a Best Ride driver on the job, I may wish to employ this person directly. Because Best Ride driver represent its inventory of skilled professionals and in the event I wish them converted to my employ, I agree to pay a conversion fee as liquidated damages. The conversion fee is \$1000. liability for the conversion fee is triggered when I hire a Best Ride driver regardless of the employment classification, on either a permanent, temporary or "as needed" basis and regardless of the driver's employment status at the time of the hire (e.g., no longer with Best Ride) or driver's claimed reason for leaving Best Ride (e.g., quit Best Ride for reasons unrelated to conversion) if said hire occurs within twelve months after the last day of the assignment.

9. If any action or proceeding is brought by either party against the other pertaining to or arising out of this contract, the prevailing party shall be entitled to recover all costs and expenses including reasonable attorneys' fees incurred on account of such action or proceeding.

10. In the event I fail to provide the required automobile insurance (see paragraph 4) herein, I HEREBY RELEASE, AGREE TO INDEMNIFY, DEFEND AND HOLD HARMLESS Best Ride and its officers, directors, shareholders, employees and independent contractors from any and all claims, demands, suits, liabilities, expenses, costs, judgments, injuries (including death) or other losses or damages which arise from or relate to Best Ride and its officers, directors, shareholders, employees and independent contractors providing services to me except for the gross negligence or willful misconduct of Best Ride and its officers, directors, shareholders, employees and independent contractors.

Terms of Service

HOURLY RATE: \$35.00 per hour for standard vehicles.

GRATUITY/SERVICE CHARGE: 20% gratuity for the driver is suggested.

MINIMUM: There is a 4 hour minimum per ride.

EXPENSES: Cost for expenses incurred by the driver including parking for the driver's car and tolls, gas and other expenses incurred while providing services to Client.

CANCELLATION: If client cancels within 8 hours of pick up time, Client will be charged the 4 hour minimum.

PAYMENT TERMS: Client's credit card will be charged upon completion of service. (except all first time clients will be charged the minimum for the day or evening up front to establish secure service).

NON-PAYMENT: In the event client's credit card is invalid and Best Ride incurs costs and/or legal fees related to the collection of the outstanding balance, Client agrees to be liable for any and all reasonable legal fees and costs, in addition to the outstanding balance.
